



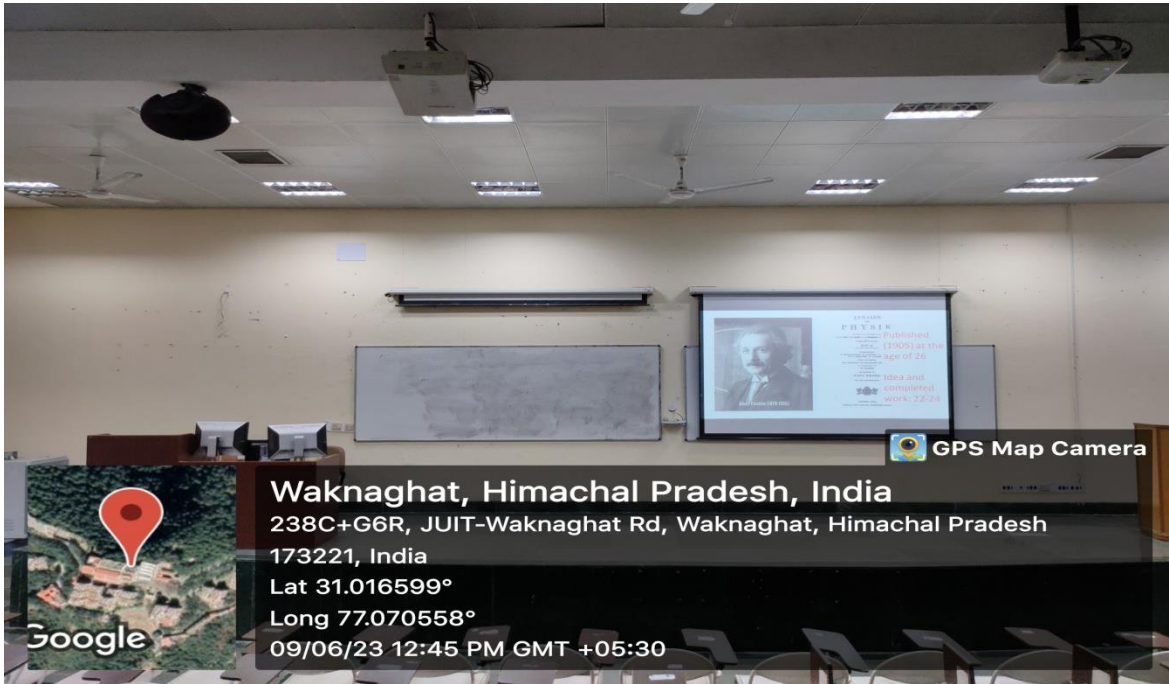

Audio Visual facility – LT3 - Image 1



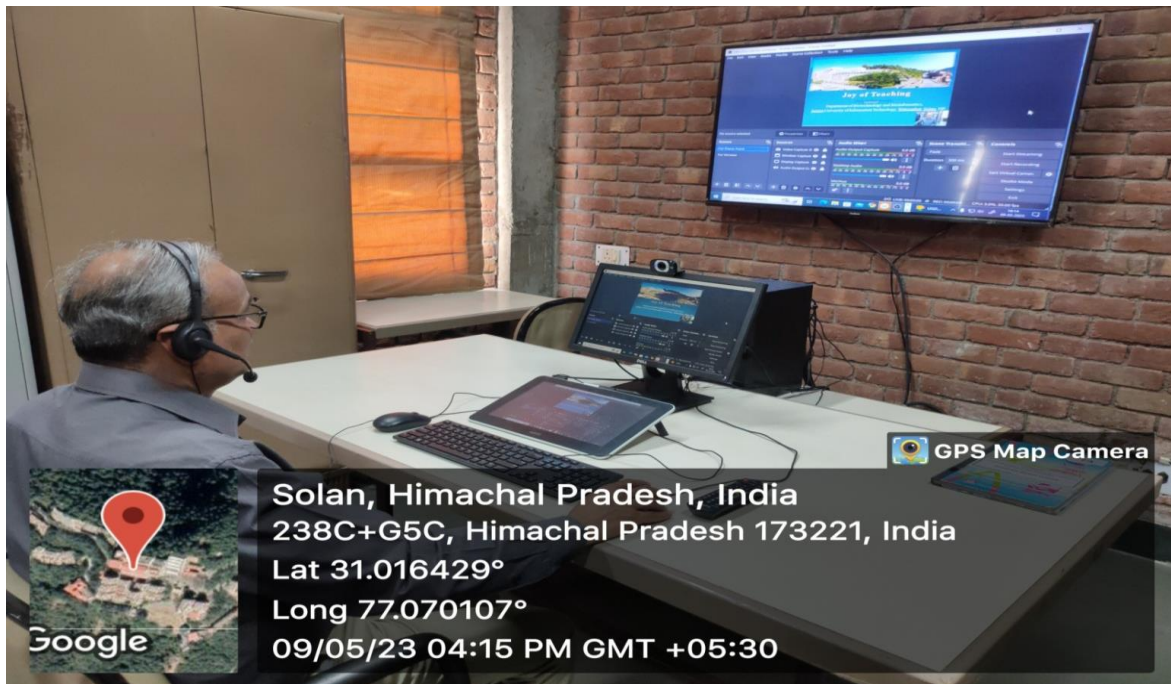

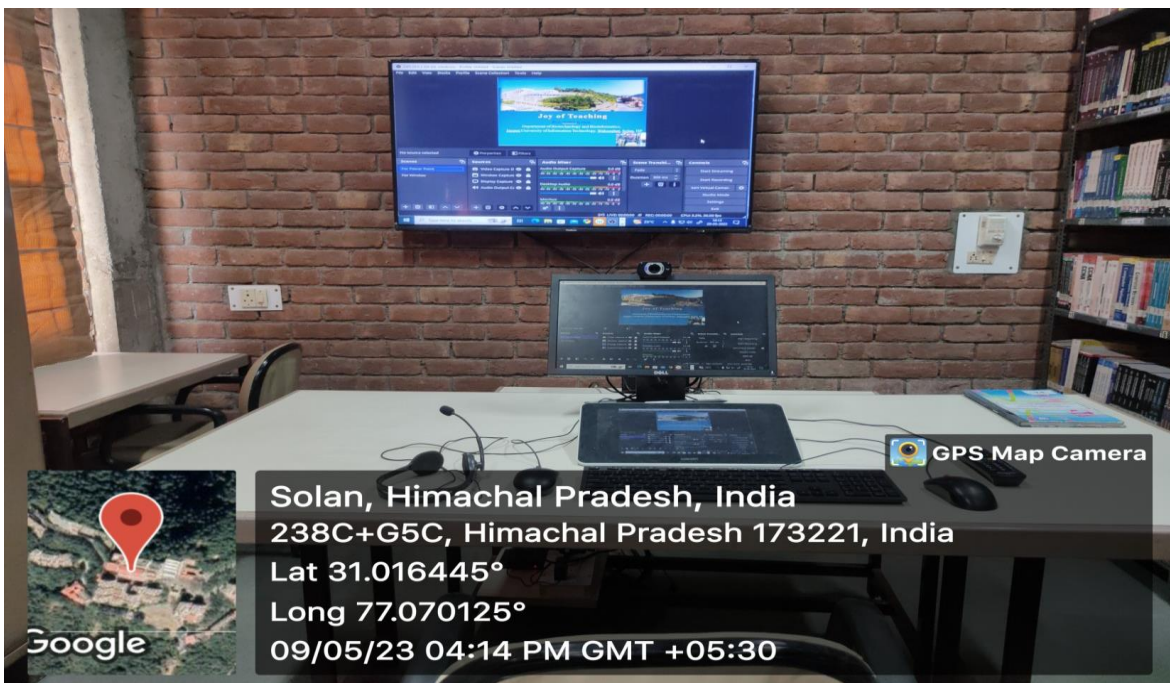
