

Mitsubishi Electric India Private Limited, a private company incorporated under Companies Act, 1956, having its Head Office at Global Gateway Tower A, 3rd Floor, Virendra Gram, MG Road, Near Guru Dronacharya Metro Station, Gurgaon, Haryana, 122002 and Registered Office at B1/G3, 4th Floor, Mohan Cooperative Industrial Area, Mathura Road, New Delhi-110044. (hereinafter referred to as MEI which expression shall unless repugnant to the context and meaning thereof shall mean and be deemed to mean and include its successors and assigns) of the one part.

Jaypee University Of Information Technology having its Office at P.O.- Waknaghat Distt: Solan (H.P.) Pin-173234 and hereinafter referred to as "JUIT" (which expression shall unless repugnant to the context and meaning thereof shall mean and be deemed to mean and include its successors and assigns) of the OTHER PART;

MEI and JUIT shall, where the context so require, be referred to jointly as "Parties" or individually as 'Party





WHEREAS

- A. The Parties had executed the Agreement dated 1st April 2023 (hereinafter referred as "Original Agreement") wherein MEI had provided Mitsubishi FA Training Equipment amounting to Rs.23,32,200/- (Rupees Twenty Three Lacs Thirty Two Thousand Two Hundred Only) to JUIT for demonstration, learning & training purposes upon the agreed terms & conditions of the Original Agreement.
- B. Pursuant thereof, MEI had entered into a Supplementary Agreement dated 19th January 2024 with JUIT, whereby MEI supplied FA Training Equipment amounting to Rs. 34,29,900/- (Rs. Thirty-Four Lakhs Twenty Nine Thousand Nine Hundred Only) without any consideration to JUIT for demonstration, learning & training purpose of the students studying at JUIT.
- C. Now once again MEI, to continue spreading awareness about automation amongst young Indian engineers and to contribute in the Indian market through its products and latest technologies, is proposed to give additional Equipment amounting to Rs.1,92,129.5/- (Rupees One Lac Ninety two Thousand One Hundred Twenty Nine and Five Paisa Only) in addition to the Equipment's already provided to JUIT, by extending the benefit of such technology to the students & staff of JUIT without any consideration and JUIT has agreed on the same.

Now therefore, this Supplementary Agreement-II by way of addendum to the Original Agreement and Supplementary Agreement executed thereof provide and confirm as under:

- 1. MEI will supply additional equipment with all accessories/attachments of latest technology amounting to Rs.1,92,129.5/- (Rupees One Lac Ninety two Thousand One Hundred Twenty Nine and Five Paisa Only) in addition to Equipment's already provided to JUIT in order to extend the benefits to the students & staff of JUIT without any consideration. The specification and scope of training equipment is more specifically given in Annexure I and II of this Supplementary Agreement-II.
- 2. The value of the equipment is Rs.1,92,129.5/- (Rupees One Lac Ninety two Thousand One Hundred Twenty Nine and Five Paisa Only) and JUIT will not make any payment to MEI for such additional Equipment, it is understood that MEI has voluntarily come forward to place its Equipment at JUIT to facilitate the institute with latest technology.

3. The additional Equipment will be placed at JUIT, from 20th June 2024 for the period till the expiry of term of Original Agreement. The dedicated space Section

Vice Chancellor)

for Equipment will be provided and contribution will be displayed at respective equipment. After completion of term, the equipment will be returned back to MEI by JUIT in good working condition considering the standard technical depreciation which may take place during the period due to usage. However, MEI may consider extending the period/replacing it with different equipment for a further period subject to mutual agreement between the Parties.

- 4. JUIT shall take the comprehensive insurance coverage for the additional equipment provided under this Agreement at its own cost to cover the accidental damage from fire, burglary, etc. if happened within the premises of JUIT and shall indemnify MEI the cost of such equipment's.
- 5. The obligation of confidentiality contained under clause 3 of the original Agreement shall apply to the equipment provided under this Agreement. However, upon expiry of the term or earlier termination, clause 3 (Confidentiality Clause) of Original Agreement shall continue to survive for a period of three years from the date of termination and **JUIT** is required to comply with the same.
- 6. This Supplementary Agreement-II shall form an integral part of the Original Agreement and the term of this Agreement shall be co-terminus with the terms of Original Agreement.
- 7. That all such terms, conditions, provisions, covenants and agreements as contained in the Original Agreement dated 1st April 2023 shall continue to remain in force and take effect read with modification as hereinabove made by this Supplementary Agreement.
