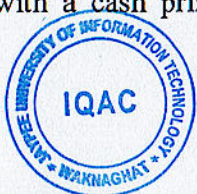
Title: “One day workshop on Patent Drafting”

On 13th October 2017 the IPR Cell of Jaypee University of Information and Technology, Waknaghat in collaboration with HIMCOSTE (Himachal Pradesh Council for Science, Technology & Environment) organized its 3rd workshop at campus premises with the support of Joint member secretary Shri. Kunal Satyarthi, IFS. The workshop was on Patent Drafting, specifically focusing on upcoming problems and solutions in Intellectual Property,

The Institute was proud to host eminent speakers in the field Dr. Indranil Saha and Ms. Ritika Kanwar. The event started off with an inaugural address by Prof. Vinod Kumar, Vice Chancellor, JUIT & Dr. Sudhir Kumar (Coordinator, IPR cell, JUIT). Dr. Indranil Saha is Patent advocate in New Delhi, a Ph.D from IISc Bangalore and LL.B (Hons. IPR) from IIT, Kharagpur. Dr. Saha initially presented his lecture on ‘Science and Patent law’.

This was followed by a lecture on ‘IPR: Problems and Solutions’ by Ms. Ritika Kanwar, also a LL.B, Hons. IPR from IIT, Kharagpur and currently working as a Patent scientist at HPPIC, Shimla.
