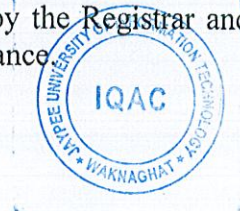



The members were also informed that the Police Authorities from Kandaghat Police Station had visited the University on 3 September 2019 late evening and the police team had been facilitated by the Registrar and Dean of Students with Chief Warden and Deputy Chief Warden in attendance.

Since the name of the victim was not mentioned in the complaint it was not possible to identify the complainant because no one had complained to the Hostel/Administration/JUIT authorities on this aspect. The Chairman sought information from the Committee Members for further course of action which was deliberated in collective forum and it was decided that the three students of 3rd year Computer Science & Engineering named in the complaint namely Mr. Vikrant, Mr. Harshat & Mr. Shubham Tyagi should be cautioned about the complaint received against them and they must cooperate in all investigations on the subject. It was also mentioned by the Chairman that he shall be meeting the three individuals named in the complaint and ascertaining their response so as to able to firstly identify the victim and secondly to caution/warn them regarding the complaint.

At the very outset Prof. Rajendra Kumar Sharma, Vice Chancellor – JUIT and Chairman – Anti-Ragging Committee welcomed all the members present during the meeting. He explained the importance / objective of the composition of the Anti – Ragging Committee to the members. The detailed agenda of the meeting was discussed among the members of the Committee. 1. **Physical Reporting of student in Campus:-** Chairman informed the members that earlier all the academic activities of the University were conducted in online mode due to COVID-19. Recently, Himachal Pradesh Private Institutions Regularly Commission (HPPEREC) has allowed to start the teaching learning activity in normal mode i.e. offline mode subject to certain mandatory conditions. Accordingly, students were informed of the same and their consent for attending University in offline mode has been taken through Google Form. The reporting of the students for on campus activities has been planned in a phased manner so as to manage the administrative arrangements. First batch, second batch and third batch have already reported to the campus on 04.10.2021, 11.10.2021 and 18.10.2021 respectively and 4th batch is likely to report on 25.10.2021.

As students have reported to the University, the likelihood of incidents related to ragging may come to notice and Anti-Ragging Committee members are expected to be more vigilant in this context.

2. **Deputation of Anti Ragging Squad:-** Chairman – Anti Ragging Committee directed that team members of Anti Ragging Squad be detailed for evening duties between 07.00 pm to 09.30 pm at all the likely places of ragging with effect from 25 October, 2021 (Monday). Team members be detailed for 02 weeks initially and later review of the activities will be taken and duty roster be extended further if required.
3. **Wardens' Round in Hostel Premises:-** Considering the possibilities of ragging in Hostel premises, he suggested that respective warden of Hostels should take round of their respective hostel at 11.00 pm in order to curb any possibilities of ragging during late hours.
4. **Inclusion of Chief Warden in Anti-Ragging Committee:-** Prof. Sharma suggested that Dr. Rakesh Kumar Bajaj, Chief Warden be included in the Anti-Ragging Committee.
5. There being no other point for the discussion, the meeting ended with vote of thanks to the chair.

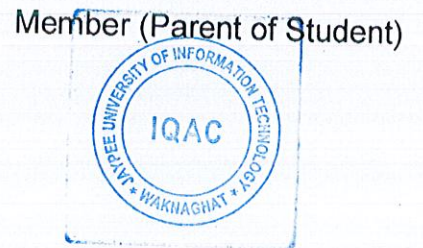

3. **Proceedings**

- (a) The Chairman welcomed all members. While 11 members were physically present, 6 members were online and balance two were on leave of Absence.
- (b) The Chairman read out the contents of the mail received by him from Anti Ragging Helpline. **Annexure- 2**
- (c) He informed the Committee Members that after intial inquiries, CCTV footages, wardens and Security In charge's reports the whole case could be understood in a better perspective.
- (d) The flow of events was narrated by him and it was informed to the Committee Members that the alleged victim had been identified and spoken to by him. The third year student (alleged victim) was satisfied with actions taken by university and that he was not scared anymore.
- (e) Some of the issues which merit highlighting in the case were then brought to the knowledge of Committee Members as under:-
- (i) Sudden disappearance of alleged victim from the scene of incident and remain untraceable till next morning.
 - (ii) Suspicion of alleged victim trying to evade alcohol breath analysis test because of prolonged absence.
 - (iii) Not contacting VC, Registrar, Chief Warden or any authority of JUIT during his prolonged absence for Help/Complaint but lodging complaint directly with Anti Ragging Helpline.
- (f) On deliberations by the Committee, it was decided that the case does not fall under the category of Ragging. Confined space of Open Cafeteria, huge crowd, accidental brushing of shoulders by the two students unknown to each other earlier leading to verbal altercation and holding each other's clothes would not qualify for Ragging.



4. The Meeting ended on the following decisions:-

- (a) Case did not qualify under Ragging.
- (b) Alleged victim's prolonged absence, not contacting any University authority on phone, false statement of mobile switched off are indicative of his evasive unjustified actions.
- (c) Termination of cultural event, move of large student crowd to hostels/cafeteria through confined space and brushing of shoulders by two unknown students is purely incidental.
- (d) Both students should be counselled and warned for their verbal altercations and actions.
