- The Programme is scheduled to commence with the registration on Sunday, 24th July, 2022 and classes will commence from Monday, 1st August, 2022 (Tentatively). In case of any change of dates, the notification will be displayed on the MDI Gurgaon website.
- In the meantime, you are required to deposit the first instalment of fees of Rs. 6,00,000 (Rupees Six lacs only) through one transaction only latest by **Saturday, 11th June, 2022 towards the acceptance of admission offer** failing which, your candidature stands automatically cancelled.
- The fee of the programme is subject to revision, the same will be put-up on the web portal in due course. Accordingly, the remaining installments of fee is to be deposited as per the timelines given.
- Please pay the instalment of fees on or before the last date of payment as mentioned above by NEFT/RTGS from any Bank having the facility of making bank transfer of money to the bank Account of MDI as per the details of the bank mentioned below. Please note that after remittance of money, you must send the following information by e-mail to admissions@mdi.ac.in with the subject 'Payment of Admission Fee', 'Instalment I' or 'Instalment II', as the case may be.

You are required to produce/submit the following certificates at the time of registration:

- Original certificates/ mark sheets of 10th, 12th, Graduation and post-Graduation (If applicable), work experience and self-attested copies of all.
- Candidates in their final year/term or candidates unable to receive their graduation final year results/certificates are required to produce proof of successful completion of the graduation on or before December 31, 2022.
- Medical fitness certificate from a qualified (Regd. Medical Practitioner) MBBS/MD from Government/private hospital.

In case of withdrawal from admission, the withdrawal intimation must be made through a reply email to admissions@mdi.ac.in with details of your Account Holder Name, Account No, Bank name and Branch, RTGS/IFSC Code.

If you withdraw on or before 13th September, 2022 the fee paid by you will be refunded after deducting Rs.1000 (Rupees One Thousand only) as a processing fee plus pro rata fee of your attendance in the programme.

In case your withdrawal communication through email is received after 13th September, 2022, there will be no refund of the fee.

The admission to the PGDM-IB Programme will be considered final only after the last date of withdrawal.

As per AICTE Guidelines, some of the seats are available under the Tuition Fee Waiver (TFW). Hence, after the admission process is over, a separate merit list of students eligible for the TFW Scheme will be finalized and the entitled students in order of merit will be benefitted accordingly under the scheme.

As a proof of the eligibility of a candidate for the TFW scheme, the candidates will be required to provide one of the following certificates:

- Family income certificate issued by any Govt. revenue authority (Year 2021-22)**
- Economically Weaker Section (EWS) Certificate (Year 2021-22)**
- Non-Creamy Layer certificate issued by a Govt. body (Year 2021-22)**
