#### TERMS AND CONDITIONS :

1. This contractual appointment is for a period of two years from the date of your joining which shall stand automatically terminated after that period. However, subject to the sole discretion of the University, a new contract for a specified term may be considered after satisfactory completion of this contract
2. During the period of contract or the extended period of contract, the contract can be terminated without notice and without assigning any reason by giving one month notice in writing by either party or giving one month pay in lieu of notice.
3. You shall faithfully serve the University, obey its lawful orders, keep it secrets, diligently and carefully learn and perform such work and business as may be entrusted to you regularly during such hours as may be prescribed and perform such duties as may be assigned.
4. You shall be subject to the Standing Orders, Service Rules and Regulations as well as the administrative orders of the University in force from time to time and shall obey all such orders and directions as you may receive from your superiors.
5. You shall devote your whole time to your duties and shall not carry on or be concerned in any other business or occupation, whatsoever. However, you may take up consultancy assignments as per the rules of the University.
6. You shall be responsible for the charge and care of the University's money, goods and stores and any property entrusted to you or in your hands and shall truly and faithfully account for or pay over or deliver to the proper person, money, goods, stores and property which shall at any time come to your hands, or under your charge, on account of the University.
7. You are, at present, posted at JUIT- Wagnaghat, Distt. Solan (HP) but you are liable to be posted at any other University/Institute at another location, run by the Trust.
